ORDINANCE NO. 26 / 2024

of the Rector of Gdansk University of Physical Education and Sport

of March 1, 2024

regarding:

rules for the recognition of documents certifying knowledge of a modern foreign language at the level of at least B2 language proficiency in the procedure for awarding the degree of doctor of physical culture at Gdansk University of Physical Education and Sport

Pursuant to § 18 section 2 point 4 of the Regulations for the award of the degree of doctor of physical culture at Gdansk University of Physical Education and Sport of October 26, 2023 (uniform text constituting Annex No. 1 to resolution No. 51 of the GUPES Senate of December 14, 2023) and Art. 11 section 2 of the Statute of Gdansk University of Physical Education and Sport of June 19, 2019 (uniform text constituting Annex No. 1 to the GUPES Senate resolution No. 52 of December 14, 2023)

it is ordered as follows:

§ 1

For a document certifying knowledge of a modern foreign language at a language proficiency level of at least B2 on a global language proficiency scale according to the "Common European Framework of Reference for Languages: learning, teaching, assessment (CEFR) - Common European Framework of Reference for Languages: learning, teaching, assessing (CEFR) in the procedure for awarding the degree of doctor of physical culture at Gdansk University of Physical Education and Sport is recognized as:

- 1) certificates confirming knowledge of English:
- a) certificates issued by institutions associated with the Association of Language Testers in Europe (ALTE), e.g. Cambridge English Qualifications ALTE levels: Level 3 (B2), ALTE Level 4 (C1), ALTE Level 5 (C2):
- B2 First (previously FCE: First Certificate in English) min. Grade C / Pass or 160 points in each part of the exam, i.e. Reading and Use of English, Writing, Listening, Speaking;

- C1 Advanced (previously CAE: Certificate in Advanced English) min. Grade C / Pass or 160 points in each part of the exam, i.e. Reading and Use of English, Writing, Listening, Speaking;
- C2 Proficiency (previously CPE: Certificate of Proficiency in English),
- Business English Certificate (BEC) Vantage min. min. Grade C / Pass or 160 points in each part of the exam, i.e. Reading, Writing, Listening, Speaking;
- Business English Certificate (BEC) Higher;
- b) Educational Testing Service (ETS), in particular:
- Test of English as a Foreign Language (TOEFL IBT) min. 87 points in the Internet-Based Test (IBT), with each of the four skills min. at the High Intermediate level (i.e. Reading min. 18 points, Listening min. 17 points, Speaking min. 20 points, Writing min. 17 points);
- Test of English as a Foreign Language (TOEFL CBT) min. 180 points in the Computer-Based Test (CBT), supplemented with at least 50 points from the Test of Spoken English (TSE),
- Test of English as a Foreign Language (TOEFL PBT) min. 510 points in Paper-Based Test (PBT), supplemented with min. 3.5 points with the Test of Written English (TWE) and supplemented with at least 50 points on the Test of Spoken English (TSE);

- d) ECL language exam (complex exam, i.e. written+oral exam) Level B2 or Level C1:

§ 2

The following may be recognized as a document certifying knowledge of a modern foreign language at the level of language proficiency of at least B2:

- 1) Polish diploma of completion of studies with a diploma supplement within the meaning of the Act of July 20, 2018, Law on Higher Education and Science (consolidated text: Journal of Laws of 2023, items 742, 1088, 1234, 1672, 1872, 2005), which indicates knowledge of a modern foreign language at the level of at least B2;
- 2) a diploma of completion of studies obtained abroad within the meaning of the Act of July 20, 2018, Law on Higher Education and Science (consolidated text: Journal of Laws of 2023, items 742, 1088, 1234, 1672, 1872, 2005) along with accompanying documentation confirming knowledge of a modern foreign language at the level of at least B2, with the exception of diplomas of completion of studies referred to in Art. 326 section 3 of this Act, and diplomas of completion of studies abroad, the equivalence of which to the relevant Polish diploma and professional title has not been confirmed through the nostrification procedure:
- 3) a certificate issued by a recognized certification center certifying knowledge of a modern foreign language not listed in § 1;
- 4) a certificate confirming knowledge of a foreign language issued by the National School of Public Administration as a result of a linguistic examination procedure;
- 5) diploma of completion of a foreign language teachers' college;
- 6) diploma of completion of the National School of Public Administration;
- 7) document confirming completion of higher education abroad or in the Republic of Poland the language of instruction is recognized if the language of instruction was exclusively a foreign language;

- 8) a document issued abroad recognized as equivalent to a secondary school leaving certificate, if the language of instruction was exclusively a modern foreign language;
- 9) International Baccalaureate Diploma;
- 10) European Baccalaureate diploma;
- 11) a document issued abroad confirming obtaining an academic degree or title or a degree or title in the field of art - the language of instruction of the institution providing education is recognized;
- 12) a document issued abroad recognized as equivalent to a secondary school leaving certificate - the language of instruction is recognized;
- 13) certificate of passing the departmental examination in:
- a) Ministry of Foreign Affairs,
- b) office supporting the minister responsible for economy, the Ministry of Foreign Economic Cooperation, the Ministry of Foreign Trade and the Ministry of Foreign Trade and Maritime Economy,
- c) Ministry of National Defense level 3333, level 4444 according to STANAG 6001;
- 14) a document confirming entry on the list of sworn translators in the Republic of Poland or a document confirming having the qualifications of a sworn translator in another Member State of the European Union, a Member State of the European Free Trade Association (EFTA) - a party to the Agreement on the European Economic Area or in the Swiss Confederation.

§ 3

- 1. Recognition of a document certifying knowledge of a modern foreign language at the level of at least B2 language proficiency within the meaning of § 1 and 2, which is to be submitted by the candidate along with the application for initiating the procedure for awarding a doctoral degree, is made by the Foreign Language Study Center of the University.
- 2. The recognition referred to in section 1, is made by stating that the document has been included in the list referred to in § 1 and 2, and providing the items from the list.
- 3. In the case of documents confirming knowledge of a foreign language not listed in § 1 and 2, the recognition of the document is preceded by an examination of

whether the document to be submitted by the candidate together with the application

- for initiating proceedings for the award of a doctoral degree, may be considered as certifying knowledge of a modern foreign language at the level of language proficiency of at least B2.
- 4. The recognition referred to in section 3, is made by stating that the document has been recognized by the Foreign Language Center of the Academy as certifying knowledge of a modern foreign language at the language proficiency level of at least B2.
- 5. A negative test result referred to in section 3, the Foreign Language Study Center of the University informs the Director of the Doctoral School.
- 6. In any case, the Foreign Language Study Center of the University may request the candidate, through the Director of the Doctoral School, to provide explanations or submit additional documents for the purpose of recognizing the document as certifying knowledge of a modern foreign language at the level of at least B2 language proficiency.

§ 4

The Foreign Language Study Center also verifies the document certifying knowledge of a modern foreign language at the level of at least B2 language proficiency in the procedure for awarding the degree of doctor of sciences in physical culture, within the scope and on the terms specified by the Scientific Council of GUPES pursuant to § 41 of the Regulations for the procedure for awarding the degree. Ph.D. in physical culture at Gdansk University of Physical Education and Sport on October 26, 2023.

§ 5

The Order of the Rector of GUPES No. 111/2022 of October 18, 2022 on the Rules for the recognition of documents certifying knowledge of a modern foreign language at the level of at least B2 language proficiency in the procedure for awarding the degree of doctor of sciences in physical culture at Gdansk University of Physical Education and Sport.

§ 6

The ordinance enters into force on the day of issuance.
